2. Objective.

To select a capable and experienced agency to design, fabricate, install, and manage KFC-branded exhibition stalls in five districts, adhering to KFC's branding and design guidelines, with a focus on quality, timely execution, and efficient logistics.

3. Scope of Work.

The selected agency will be responsible for:

- Setting up exhibition stalls (3m x 2m) at the specified venues.
- Fabricating stalls using plywood with paint finish.
- Installing a 50" display screen in each stall for video streaming.

- Creating an interactive game zone with touchscreen and video display, along with spot prizes.
- > Setting up a social media campaign zone with associated giveaways.
- Implementing thematic lighting and sound design.
- > Managing transportation, installation, and dismantling of stall infrastructure.
- Providing all necessary utilities: lighting, electrical setup, internet, furniture, and branding elements.
- Ensuring hygiene, safety, and high-quality execution.
- Coordinating with KFC's local branch team for smooth operations.
- Photo and Video Recording of the inaugural session at each venue.
- Photo and Video Recording of the conclusion session at Thiruvananthapuram.

4. Eligibility criteria of Agencies.

Only agencies empanelled by PRD in Category B (Print/ Outdoor Creatives) as per GO (MS) NO.4/2024/I&PRD dated 20.02.2024 shall apply.

However, in case of a change in dates or change in venue or change in districts, the agency should be willing to set up the stalls accordingly.

6. Evaluation Details.

EOIs will be evaluated based on:

- **Technical Score (70%)**: Based on stall design, layout, engagement concepts, execution strategy, timelines, and resource planning.
- **Financial Score (30%)**: Based on the cost quoted.

Final selection will be based on a combined score (Quality and Cost-Based Selection method).
