## 2. INTRODUCTION

Kerala Financial Corporation (hereinafter referred to as KFC), a State Financial Corporation established under Section 3 of the SFC Act 1951, invites tender for disposal of 1 Office vehicle, Maruti Suzuki Swift Dzire (2010 model) on tender cum auction basis.

## 3. Terms and Conditions

- a. Sealed Offers are invited for the disposal of one used Office Car, Maruti Suzuki Swift Dzire (2010 model) bearing Registration number KL-01-AZ-3050 (Maruti Suzuki Swift Dzire LDI, CC:1248, 5 Seater, Net value of asset: 1.50 Lakh +GST as per applicable Rules). The last date for submission of sealed offer is 13.03.2026 at 4.00 PM.
- b. The tenders will be opened on 16.03.2026 in the presence of the available bidders/representatives, after completion of Auction as per the (3.D) below, at "Kerala Financial Corporation, Head Office, Vellayambalam, Thiruvananthapuram, 695033".
- c. The amount that can be offered for the vehicle shall be furnished in the prescribed format. Tender document fee Rs. 500/- + GST and EMD of Rs.10,000 /- as two separate Demand drafts in favour of Kerala Financial Corporation is required to be furnished along with the Rate offer in the prescribed Format.
- d. There will be an auction to be conducted at 11.00 AM. on 16.03.2026 with a reserve price of 1.50 Lakh.
- e. The Sale of vehicle will be confirmed in the name of highest bidder who offers the same either in auction or in the Sealed Offer. The Vehicle will be transferred in the name of the successful Offeror for which details are required to be submitted by the bidder after the auction is confirmed.
- f. The successful bidder shall deposit 25% of the price immediately, failing which confirmation will not be made and the EMD will be forfeited.
- g. The successful bidder has to shift the vehicle from the KFC premises within 10 days after remitting the balance amount and completing all formalities including transfer of ownership procedure. In case of failure

to remit the amount and shift the Vehicle within the above-mentioned time period, the confirmation will be cancelled by forfeiting the EMD and the amount paid and the vehicle will be disposed off otherwise.

- h. These tender conditions can be downloaded from the website and the same has to be signed by the bidder and to be submitted in sealed cover along with the rate offer and EMD super scribing "Offer for the sale of Maruti Suzuki Swift Dzire (2010 model) KL-01-AZ-3050" along with EMD receipt, amount offered in the prescribed format and a photo ID proof at the Registered Office at "Kerala Financial Corporation, Head Office, Vellayambalam, Thiruvananthapuram, 695033".
- i. The vehicle can be inspected on any working day between 11.00 am to 4.00 pm at Head Office, Vellayambalam, Thiruvananthapuram, 695033 till 13.03.2026.
- j. The vehicle will be disposed of on "**AS IS WHERE IS BASIS**" and "**NO COMPLAINTS BASIS**".
- k. KFC shall have the right to accept or reject any tender without assigning any reason.
- l. All disputes arising out of or related to this tender shall be subject to the exclusive jurisdiction of the courts at Thiruvananthapuram, Kerala.
- m. All bids shall remain valid for 30 days from the last date of submission. Withdrawal or modification during this period will lead to forfeiture of the EMD.
- n. The successful bidder shall indemnify KFC from any claims, liabilities, damages, or legal proceedings arising from the use or transfer of the vehicle after completion of sale.
- o. KFC shall not be responsible for any defects, latent or otherwise. No claims for compensation, repair, or deductions will be accepted after the sale. Bidders are deemed to have inspected the vehicle or chosen not to do so at their discretion.
- p. KFC reserves the right to cancel, modify, or amend any part of this tender at any stage without assigning reasons. No compensation or cost will be payable to any bidder for such actions.
- q. If the successful bidder fails to comply with payment timelines, documentation, or vehicle removal requirements, KFC may cancel the award and forfeit the EMD and any payments made, without prejudice to its right to re-tender or re-sell the vehicle.
- r. All expenses relating to ownership transfer, taxes, insurance, and statutory charges shall be borne entirely by the successful bidder. KFC bears no responsibility for RTO procedures.

- s. Bids submitted are non-transferable. A bid submitted in the name of one individual/entity cannot be assigned or transferred to another.
- t. If any information provided by a bidder is found to be false, misleading, or incorrect at any stage, KFC may cancel the bid, forfeit the EMD, and debar the bidder from future tenders.
