Pursuant to Regulation 60 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation of our earlier intimation of record date dated 16.02.2026, we wish to inform you that the interest payment on the KFC 8.90% Non-SLR Bonds – Series I/2023, originally scheduled for 31st March 2026, will be processed on 04th April 2026. This is in view of holiday in Mumbai on 31st March 2026, on account of Mahavir Jayanti. Further, 1st April 2026 is a Bank holiday, and 2nd and 3rd April 2026 are also holidays in Kerala due to Maundy Thursday and Good Friday.

As per the Information Memorandum of 8.90% bond if the scheduled date falls on a non-working day, the payment will be made on the next working day. Since 1st April 2026 is a Bank holiday, and 2nd and 3rd April 2026 are also holidays, the interest payment will now be processed on 04th April 2026.

We have obtained the necessary approval from our Debenture Trustee to process the payment on the revised date. We are coordinating with our bankers to ensure timely processing and will keep the exchange informed of any further developments, if required.
